The practitioner must possess the ability to analyse accurately the information gained from all areas of an investigation/assessment in order to produce acceptable and accurate outcomes that are in the express intersts of the child.</p> <p>Building on Lord Laming's recommendations this course aims to improve the skills of the pratiitioner in order that they are able to conduct effective and professional investigations from the start of a child abuse referral.</p>
