This will enable us to give specific advice to the individual and be able to send follow up advice after the session. Then, if they needed any further support with their application, the contact has already been made so we will be able to continue to assist them. This has been a very effective tool that we have used multiple times for Cardiff University. Webinars can be targeted at those applying to the scheme and/or HR staff. This webinar can include general information on the EUSS, 2021 Immigration Rules, Skilled Worker visa, Health Care visa and some general information on indefinite leave to remain (if this is wanted). If multiple teams just want a webinar on the EUSS but catered towards social care workers, then we can do this too.
