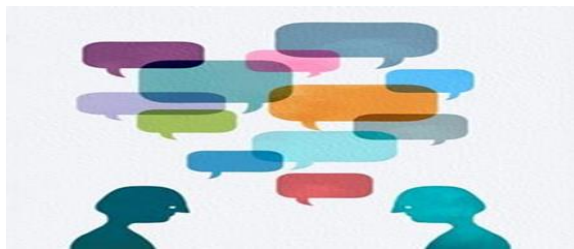

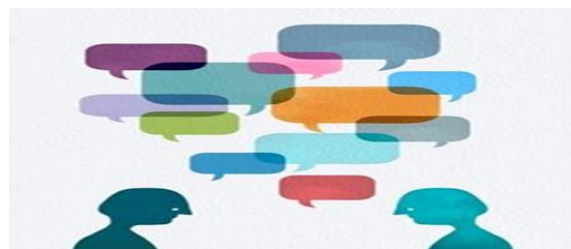

- We have worked with people from across Black, Asian and Minority Ethnic communities in Wales to put together the Anti-racist Wales Action Plan.
- We want to make a real difference to the lives of current and future generations of ethnic minority people. All of us have a part to play to help make Wales a place where everyone feels safe and valued. This is about fairness for all.
- The plan sets out how the Welsh Government and its partners will work towards a fairer, more equal nation, and focuses on 6 areas where ethnic minority people experience racism:

  - as refugees and asylum seekers.

- people in power taking action to tackle racism within their organisations
- respecting difference and valuing our many diverse and unique identities
- actively working to make society fairer for everyone.

## What has been achieved so far through ArWAP?

We're already making a difference through the plan. We're proud that Wales is the first country in the UK to make the teaching of Black, Asian and Minority Ethnic histories mandatory in the Curriculum for Wales. We're breaking down barriers that cause health inequalities, improving support for victims of racially motivated hate crime, taking steps to improve diversity in public life and funding projects that support greater participation in culture, heritage and sporting activities. We're also listening to lived experiences of racism to make sure that the actions we take bring about the changes people want to see.
